



Dear Sponsoring Member:

The Alta Club has adopted the following procedure for introducing a prospective member to the Club:

Prospective members must be nominated as a candidate by a member of the Alta Club who will serve as the sponsor. The sponsor will guide his or her candidate through the process and will act as the candidate's liaison with the Club. The sponsoring member may pick up an application from the Club, have it sent electronically and/or deliver it to the prospective member. Upon request, the Club will send electronically or via mail an information packet to a prospective member's email address, home or office. The Board also recommends the sponsoring member to write a letter describing their relationship with the prospective member.

The candidate must complete the application for membership, including signatures from the proposing member and three co-sponsors, all of whom must be either a Resident, Corporate, Junior, Legacy or Emeritus Member. **The application must be submitted to the Club's General Manager by the second Thursday of the month.** The General Manager and Membership Committee Chair will then present the application at the next Board of Directors Meeting (held on the third Thursday of each month at 4:00 pm). The sponsoring member should accompany his or her candidate to the Board of Directors meeting to introduce them to the Board at 5:00 pm. After meeting the candidate, the Board will vote on whether to post him or her. The posting period lasts approximately one month, or until the next Board meeting and allows the membership committee to contact all of the sponsors, investigate the candidate's qualifications for membership, and notify the entire membership of the candidate's application. Following the posting period, the Board of Directors will vote on whether to approve the candidate's membership application.

If approved, the new member will receive a welcome packet and an invitation to the next Club Night. As the sponsoring member, please plan to introduce our new member to the Club, accompanying him or her to a Member Event, Library Forum or even lunch at the Member's Roundtable. It is only with an active sponsor that a new member will understand all the benefits of the Club and thus make the most of his or her membership.

Applicant understands the Club, for purposes of considering his or her membership proposal, will investigate the applicant's education, financial responsibility, social position and general reputation, and those same attributes of members of the applicant's family. All such information so gathered will not be disclosed to the applicant, and the applicant agrees never to make demand upon the club or other person for disclosure of this information. If elected to membership, the applicant agrees to abide by all of the existing or amended By-Laws, Rules and Policies of the Club as set forth by the Membership and the Board of Directors.

Applicant understands that if their account becomes 30 days past due, they will be charged interest on the outstanding balance at the rate of 3% periodic interest and will receive a friendly reminder letter. If their account becomes 90 days past due, club privileges will be suspended. If their account becomes 120 days past due, (i) it will be sent to a collection agency, (ii) membership will be terminated, and (iii) the member will be responsible for all collections costs and expenses including reasonable attorney's fees. During the review of a membership proposal, the Club may obtain a consumer credit report on the applicant. If asked, the Club will disclose the name and address of the consumer reporting agency that furnished the report.
